



## TIMMINS POLICE SERVICE AUCTION RULES

1. A bid by any person shall be conclusive proof the person is acquainted with these conditions of sale and has agreed to be bound by them.
2. Bids will be made in \$1 increments with no cents. Bids made in unacceptable intervals will be ignored and users found to be frequently posting such bids risk being removed from the site.
3. All items are posted on Fridays at 12:00pm (noon) and will be posted for 7 days. Bidding closes at exactly 12:00:00pm the first Friday after the item is posted. The last accepted time for a winning bid is 11:59:59am.
4. Winners will be notified by email with instructions of how to pay for and pick up your item.
5. All auction items are seized, forfeited, or found and should be considered "used" unless otherwise noted. All items are in **as is** condition with no warranty expressed or implied.
6. A description and picture(s) accompany each auction listing. While we endeavor to accurately describe and portray each item the TIMMINS POLICE SERVICE cannot supply the type of information a buyer might expect from a manufacturer or owner.
7. Do not make assumptions regarding any features, functionality or additional parts/accessories not pictured or described. The original manufacturers for some items may consider the item old or out of date and therefore no longer provide customer support for the item.
8. Though all written descriptions are believed to be correct, the TIMMINS POLICE SERVICE makes no warranty or representation of any kind with respect to the property and in no event shall be held responsible for having made or implied any warranty of description, genuineness, authorship, attribution, providence, period, culture, source, origin, condition, etc.
9. If the TIMMINS POLICE SERVICE discovers an item is listed incorrectly, recalled or other important information about the product is learned, the TIMMINS POLICE SERVICE reserves the right to remove the item and/or cancel any bids or transactions.

In an effort to keep the auction site free from mischievous bidders (those who bid on items with no intention of paying for them), we reserve the right to cancel bids and/or restrict the use of the site. The Timmins Police Service retains the right to reject membership to the Timmins Police Service Auction site at any time, for any reason, without providing notice or explanation.
11. If you place bids on multiple items, you must complete each transaction on all items won. Some items may indicate alternate payments by certified cheque or money order. Auction items may have alternate arrangements for specific viewings and payments, i.e. vehicles or large items.
12. Requests to remove a bid is prohibited and the account will be flagged. We do not allow multiple accounts from the same person.
13. Items are sold in 'as is' condition. All sales are final. **NO RETURNS** are accepted.

Each participant represents and warrants all personal information provided to the Timmins Police Service during the registration process or through any other feature on this website will be true, accurate, current and complete. Participants will promptly update their information to keep it true, accurate, current and complete at all times.
15. The TIMMINS POLICE SERVICE may refuse any or all of the services to anyone at any time, at the sole discretion of the TIMMINS POLICE SERVICE.
16. Taxes are applicable on the winning bid and calculated at checkout. All funds are accepted in Canadian (CDN) dollars.
17. The Timmins Police Service retains the right to change, add, or remove rules for Timmins Police Service Auctions without posting a public notification.
18. If you believe a posted item belongs to you, please contact the Timmins Police Service with proof of ownership. Once reviewed, if ownership is confirmed, your item will be returned to you.
